AMEND BROWNFIELD LOAN TO TODA/BASF

Mr. Sobieralski proposed taking the TODA dollars from the BCBRA rather than a loan from the BCTIFA to the BCBRA.

MOTION: Mr. McKernan moved that the Battle Creek Brownfield Redevelopment Authority

Board of Directors approve the \$300,000 loan to TODA/BASF from the BCBRA instead of BCTIFA loan to BCBRA. Ms. Fleury supported the motion and it was

unanimously approved.
